Minutes of the Ordinary Meeting 7th August 2025 Kinlochard Village Hall 19.00

Councillors Present: Paul Scrase (PS) (Chair), Nick Lester-Davis (NL) (Vice Chair), Joyce Kelly (JK) (Planning), Natasha Sheppard (NS),

Prior to moving on to official business, PS began by presenting a tribute to Ros Dingwall whose funeral was today. Originally from Glasgow, Ros moved to Aberfoyle many years ago and was the Postmistress in Aberfoyle for 40 years. Ros was an important member of the Community and dedicated over 25 years of service to SCC. She will be greatly missed by all who knew her. A minutes silence was held in her memory.

1. Apologies: Noted above	
2. Minutes from 6th June Meeting: Proposed by JK and seconded by NS; no matters arising.	
3. Co-Opting of new Community Councillors: Oliver Godby has kindly stepped forward as a new Community Councillor and has completed all the paperwork which has been checked and approved by Stirling Council. NS Proposed his appointment; seconded by NL. PS announced him as duly elected.	
4. Beaver Translocation Update: KA of FLS has worked closely with The Beaver Trust and other agencies for a number of years monitoring the health and welfare of the Beaver population in the area. She provided some background by mentioning there have been beavers living in the local area for many years and were first spotted in Loch Venacher and Loch Achray about ten years ago. It was assumed they arrived through natural dispersal. Then about three years ago, signs were that they were in the Doune Hill area and in Loch Ard itself, in the 'narrows'. Signs of their existence seemed to pop up more and more frequently.	

At the same time, Scottish Government, were pushing for Agencies to provide translocation sites to help with populations elsewhere that required a more suitable habitat. There was a particular problem in Tayside where some interference with prime agricultural land was occurring. Licences to Kill were being issued to farmers in the area, which was not an ideal situation to have. New sites in areas seeking increased biodiversity and where holding back and slowing down water were a priority, were being sought. Various sites around Aberfoyle and Kinlochard were identified by FLS. Mapping was made of the area and shared with members of the community.

Translocation of some Tayside Beavers started early last year when a family group of three were translocated into the top end of Duchray Water. Then in the Autumn two family groups were introduced to two other sites and then three pairs into small lochans in the forest. All the sites are lochans, which are deemed excellent locations with water 1.5 metres deep and slow flowing. In total, there were 20 beavers released, with the last two being at Lochan Spling in February this year. They have all stayed in their sites and monitoring continues. All appears to be going well for them.

PS asked what the process for monitoring is and what is the plan moving forward? KA responded by saying there will, indeed, be impacts on the environment. Beavers will fell trees and will dam watercourses. FLS don't really call it a 'Management Plan', as such. They do, however, observe their habits and report on any issues that arise. FLS can provide advice on removal of dams etc. should there be any negative impacts on local residents. Mink and Water Vole monitoring is also going on in the area.

IP from Nature Scot also confirmed there will inevitably be an impact. These should be accommodated in the habitat they reside. However, should there be any conflict then Nature Scot should be the first point of contact.

JK asked for a clear point of contact. This was confirmed as beavers@nature.scot. There is also a hotline number (01463) 725364. PS confirmed he would put these details on the SCC website.

A member of the public asks: What to do if you have a problem on land near your own but the neighbour does nothing about it? IP said there is no legal mechanism to enforce landowners to do anything and the only advice he can give is to talk it through with them in an attempt to resolve any issues and Nature Scot will help in any way they can. How about injured beavers? - In the case of an injured animal SSPCA should be the first port of call. Breeding habits? - beavers tend to have one litter per annum of usually two kits. A territory will only support so many individuals and there is a natural migration process which prevents territory saturation.

Another member of the public talked about how he has erected remote cameras at the bottom of his garden to monitor a family of beavers who, this year, had three kits. They have a number of lodges and erected a 2 ft high dam which didn't stop the flow of water but does leave large puddles. A discussion took place as to the pros and cons of installing signage to warn kayakers of their

presence. However, it was thought that, on balance, it was probably not a good idea as it may entice more (not less) paddlers to the area.

IP encouraged anyone who has a siting to report them to Mammals Society <https://mammal.org.uk> as this will assist with the annual survey (of Beavers) that takes place each year.

PS thanked IP, IB and KA for their time and for the useful information after which they left the meeting.

5. Police Report – Agenda item moved up the table so as not to hold Sgt Dempster (DD) back too long. DD has recently moved into his position as Sargeant, started on Monday 4th.

Particular discussion about how dog incidents are handled. Care was made not to mention names or specific incidents but there was a lot of interest by the public of the subject matter. DD stated he is still getting up to speed himself, but is aware of the police having a close working relationship with the local dog warden. Mention was made of a ‘dog control notice’. These state the dog owner must bring the dog under control and may be fined if they fail to do so and/or be banned from owning a dog. In the case of a dangerous dog, it may also be destroyed.

It remains quite difficult for the public to know what the terms of a control notice are, as they are not publicised. Therefore, it is up to the public themselves to report any incidents when they occur. The police and dog warden will deal with incidents in the appropriate way.

Questions from the public – Guidance on good practice as regards anti-social behaviour i.e. noise early in the morning or late at night from dogs? DD believes this is a neighbourhood issue but perhaps the dog warden could help answer this type of question. When does a ‘control order’ become a ‘criminal order’? DD wasn’t sure whether one supersedes the other or whether they can run concurrently. At what point does an issue become public? One member of the public suggested that it must be already public after it was reported in the press. DD agreed.

With many questions still to answer about ‘best practice’, DD suggested the Dog Warden could, perhaps, be a good person to talk to. PS marked an action to invite him/her to a future SCC meeting.

Moving on to the Police Report – See Appendix 1. DD ran through the report compiled by Donald King. Mention was made of a disturbance at a local licenced premises (arrest made), damage to a vehicle and fence (enquiries on-going), RTC in June (drink driving arrest made). DD stressed to be vigilant about door step salesmen and advises against engaging with any cold callers e.g. tarmac and driveway work. He also mentioned there is a known individual operating through an Organised Crime Gang stealing agricultural machinery. The Local Police are targeting him specifically and hopeful of an eventual arrest.

PS thanked DD for his time at which point he left the meeting.

<p>6.Ongoing Business / Enquiries Made – PS confirmed he is still waiting for confirmation of when the new speed sign will be installed near the play park. No date given yet. Speeding issues outside Forest Hills remain a problem and everyone was reminded to ‘Report it’, even if you don’t have the car registration number. Nothing will be done until the Health and Safety (roads) have sufficient data.</p>	
<p>7. Stirling Council update – EW confirmed that not much is happening as the Council is in summer recess at the moment. They return back at the same time as the schools. Work does carry on in the background but other than a recent councillor resignation (Brian Flannagan) resulting in a by election in Oct/Nov, there is nothing much to report.</p> <p>Work carries on collating the Visitor Levy feedback following the recent public consultation. On a personal note, she has been busy attending various Highland Games, the most recent being Bridge of Allan, with another one next week. Always a good day out. She also mentioned the VJ Celebration coming up on 26th August at Stirling Castle with all welcome to attend.</p>	
<p>8. Matters Arising -No matters arising and members of the public left at this point.</p>	
<p>9. Treasurers Report – See Appendix 2 . Available funds as at 7th August amount to £4248 after various administrative expenses, business hub membership and bank charges. £100 is ringfenced for Strathard Framework Minute Secretary payment following contributions from Framework partners. CC mentioned, via email, that she has completed and submitted the admin/minute taker grant applications to Stirling Council for the up-coming year. The bank account is finally switched over to an online accounting version which will make things easier for payments in the future with less need for cheque writing.</p>	
<p>10/11. Nothing to report from the Flooding Team for this month.</p>	
<p>12. Strathard Community Trust update (SCT) – OG has kindly offered to be the link with SCT and will keep SCC up to date with everything going on there. The main thing to report this month is that Kate Bovill is still working her notice period which will expire on Sept 1st. She has kindly agreed to continue providing 1 day/month to help with various admin functions. The Trust is applying for funding in order to recruit a replacement Development Officer but, so far, have been unsuccessful. They have been advised to keep applying (every 3 months) and there is discussion about offering a temporary post to be paid from existing funds in the meantime. Nothing decided yet.</p>	
<p>There is good dialogue with the manager of the new Cobbs shop who remain supportive for any Community initiatives going forward. Aberfoyle Book Festival is happening 10- 12th October and SCT are looking for extra funding for that. Also looking to fund a Promotional Video. EW advised an approach to Visit Scotland and/or Rural Network Scotland and to call Stirling Council Economic Development Dept. OG noted her advice. SCT AGM is end of September.</p>	

<p>13.FLS – nothing to report / LLTNPA – See Appendix 4. PS has received a report from Gordon Watson which he read out. It was mainly about various visitor pressures that remain challenging in specific areas around The Park e.g. Luss. There has been some aggressive behaviour towards Park Rangers which is totally unacceptable. The National Park Youth Committee have set up an Instagram Channel to engage the younger generation with all the fabulous things LLTNPA has to offer. Mention made of the Trossachs Explorer being back in service and operating from Drymen. The issue of camping permits continues to be dependant on the weather but there were a couple of weeks in July with full bookings. Water Safety events continue. Reference was also made about the recent Scottish Government decision regarding the Lomond Banks Planning application. A very strongly worded letter has been sent to Government outlining the LLTNPA Board's serious concerns about the whole process.</p>	
<p>14. Life Plans – JK reported that a meeting has finally been arranged on 26th August with the three life plan partners i.e. Mark David, Wendy Fawkner and Joyce Kelly. It is important to ensure the Life Plans are working together to ensure they are included in the overall Local Development Plan. JK will report back, as appropriate.</p>	
<p>15. Planning – See Appendix 3. There were 7 new planning applications during the period which are detailed in the report attached. Probably the most significant one relates to 20 affordable housing units in Braeval. The housing is much needed so expect it to have SCC support. However, this is at a very early 'first' stage and it is only after this stage that RSHA will move forward to fundraising for it.</p>	
<p>17. AOCB – NS asked about the Kinlochard Playpark following the recent survey that went out. PS confirmed that no feedback has come back yet but once it does they will press ahead to action any findings.</p>	
<p>18. Close- PS declared the meeting closed and confirmed the next meeting to be on 4th September at Aberfoyle Memorial Hall.</p>

recent visitor management pressures

Following an extremely busy weekend due to warm weather conditions, Gordon Watson issued a statement this week thanking the majority of visitors who enjoyed the National Park responsibly and safely.

Despite considerable efforts in place to manage very high visitor numbers, unfortunately our teams encountered challenging conditions, particularly at popular locations including Milarrochy Bay, Luss and Balloch. Our teams, working alongside Police Scotland and Local Authorities dealt with high numbers of irresponsible and illegal parking, littering, water safety incidents, as well as numerous byelaw infractions.

Unfortunately, Gordon did have to address that our National Park Rangers faced completely unacceptable aggressive behaviour from some members of the public while carrying out their duties to protect both people and the environment. And he stated that this behaviour towards our staff and the staff of our partner agencies is entirely unacceptable and will not be tolerated.

Running until 5th October, this year's expanded service draws on extensive feedback and evaluation from 2024, when 91% of surveyed passengers said they would use the shuttle bus again. New improvements include an extension to the route, now starting from Drymen, better connections to existing public transport services, new local operator McColls, and more accessible buses.

Visitor Management update

Digital visitor management work

The Visitor Operations team along with the Ranger Service have been working on a digital project that came from the Explore Outdoors [CivTech 6 challenge](#), which asks - "How do we better plan, manage and respond to the experiences of visitors and communities at visitor hotspots in rural and remote locations?"

In response, a web-based map was developed for the National Park showing real-time data such as footfall, car parks, and weather. This allows us to:

- Anticipate demand and planning for future visitor numbers
- React to sudden increases in visitor numbers
- Reduce irresponsible behaviours
- Monitor trends and the impact of interventions to support investment planning
- Encourage responsible visitor behaviour by educating visitors as to where to park, where to visit, check car park busyness and more
- Assist with digital communications to stakeholders
- Enable organisations to participate in data-driven knowledge sharing across the sector.

The public-facing map went live last summer, providing information for visitors on where, when and how to visit. This draws information from sensors and data sources along with data fed in by National Park Rangers, resulting in a game-changing tool for reviewing activity, understanding visitor patterns, deploying resources and making decisions on managing visitor pressures.

This project is a partnership between the National Park Authority, Interface, Perth and Kinross Council, Stirling Council, The Scottish Government, Censis, Scottish Local Government Digital Office and Whereverly.

This project was nominated and has gone on to be shortlisted for the [Scottish Thistle Award](#) for Innovation.

Camping

As expected, permit and campsite occupancy rates are very much dependant on the weather. The recent improvement in the weather, and schools finishing up for the summer break, has seen a rise in camping numbers, particularly last weekend when we were at capacity across almost all permit areas and campsites.

The group application process has seen the busiest year to date. 34 applications were provided permits and/or pitches to camp throughout June and a further 7 applications into July. These allow DofE, Scouts, schools, and social inclusion groups the opportunity to get out into nature.

Ranger service

We have continued our pop-up water safety events, with our next engagement being the World Drowning Prevention Day on Friday 25th July at Lomond Shores. These events provide a good opportunity for the National Park Authority to work closely with partners to deliver water safety messaging.

Preparation has begun for the fifth [Go Swim](#) Event taking place on Saturday 30th August. The event will again use The Duncan Memorial Slipway. Go Swim is a fantastic platform for swimmers of all ages and abilities to try or improve their outdoor swimming skills in a safe environment.

So far this season, Rangers have engaged with over 2000 people whilst patrolling, and they continue to promote and encourage responsible behaviour, and offer water and fire safety advice. Unfortunately they have also taken details from 160 people in contravention of the Camping Byelaws and had to remove over 350 bags of litter.

Lomond Banks

The NP received a procedure notice from the Scottish Government Division for Planning and Environmental Appeals. Given this stated procedure is most unusual and does not follow normal practice when Scottish Ministers call in a planning appeal for determination and having consulted with the NP's board convenor and vice convenor, and having taken legal advice from Anderson Strathern – Gordon Watson has written to the Scottish Government Chief Planner to set out, in the strongest terms, our significant concerns regarding the inherent unfairness on how the latest process has been set out.

Gordon has received an acknowledgement from the Chief Planner and will continue to keep Board Members informed of further developments.
